Re: Return of illegally collected money

On behalf of the Traditional Karate Federation of Poland (PZKT) we are writing this letter with demand to return illegally collected money which were transferred by PZKT to the ITKF account during time of the ITKF suspension which has lasted since May 1, 2002.

In accordance with information received by the Law Firm Porczyński Owczarek and Company, the suspension of a corporation in California means:

“When a corporation is suspended, it has lost all rights and privileges as a corporation and cannot legally operate. In that regard, technically a suspended corporation is required to close its business and stop all business related activity. Moreover, a suspended corporation cannot sue or defend any action in court. Furthermore, a **suspended corporation that provides a service, or goods, to third parties while suspended may not be able to collect payment for such services or goods since the suspended corporation technically was not permitted to engage in any business transactions**”.

For many years our federation being completely unaware of the ITKF status has made payment of funds to the ITKF account for various purposes, including membership dues, ranking certificates, testing fees, etc. **According to available records since 2010 we have transferred to the ITKF account the total amount of 31.860 USD** listed below which can be checked in the attached confirmation of payment printed from our bank system.
